ORDINANCE 1959

AN ORDINANCE AMENDING SCHEDULE A, AN ADDENDUM TO THE MUNSTER CODE OF ORDINANCES PERTAINING TO FINES, FEES, AND PENALTIES

WHEREAS, the Town Council of the Town of Munster is the municipal legislative body of the unit: and

WHEREAS, The Town of Munster, its Staff, and consultants have reviewed and recommended various changes to the Munster, Indiana Code regarding Schedule A, an addendum to the Munster Code of Ordinances; and

F.6 In order to be eligible for the discount:

- **a.** The applicant must register all eligible units for inspection at the same time.
- **b.** The \$200 fee must be paid in full at registration. Rebates for discounts will be given after inspections are completed.
- **c.** Inspections of less than eight (8) units will be arranged to be completed in one mobilization. The Chief Building Inspector may authorize more than one mobilization if he deems it necessary because of logistical issues.

- **d.** In cases where there are more than eight (8) units, owned or operated by one individual or management company the inspections may be divided up into multiple visits and the landlord will still be eligible for a discount. The Chief Building Inspector shall determine the number of units that can be inspected on each visit, to remain eligible for the discount.
- **e.** Any unit failing the inspection will not be eligible for the discount. All units passing will remain eligible for the discount based on the number of units that pass.

A.17 Billing of Accounts with Compound Meters

The monthly water billing for accounts in Munster with compound meters shall be calculated by combining the consumption measured through the low flow and high flow gauges and applying the total consumption based on the minimum usage established for the larger meter. Effective with the bills due January 21, 2019. (Ord 1752, 11/5/18)

- **A.18** Estimating Accounts Meter readings are collected remotely on or about the 15th of each month. If a meter reading is not captured on a given month, a second attempt is made. If no meter reading is captured on the second month, usage will be estimated, and penalties assessed as follows:
 - **a.** First month with no meter reading captured: The usage for that billing period will be estimated by taking the average of the past 12 (twelve) months of usage.
 - **b.** Second month with no meter reading captured: The usage for that billing period will be estimated by taking the average of the past 12 (twelve) months of usage and the property will be tagged requesting the customer contact Water Billing to arrange for a maintenance call to examine and possibly change the meter.
 - **c.** Third month with no meter reading captured and no response to the tag issued in the second month as described in 2.A.18.b above: The usage for that billing period will be estimated at double the 12 (twelve) month average and the property tagged a second time.
 - **d.** Fourth and each subsequent month with no meter reading captured and no response to the tag issued in the third month as described in 2.A.18.c above: The usage for that billing period will be estimated at double the 12 (twelve) month average and a non-refundable fine of \$50.00 will be assessed.

- **A.2** Any person cited for violations of the above ordinance or code provisions shall be entitled to pay the fine set out above at the Violations Bureau within thirty (30) days of issuance of the citation, without the necessity of appearing in court.
- **A.3** Any person paying a fine at the Ordinance Violations Bureau shall execute a waiver of right to trial and an admission of the violation.
- **A.4** Any person intending to contest a violation within the jurisdiction of the Ordinance Violations Bureau shall execute a written denial of the violation, and thereafter the alleged violation shall be filed with the Clerk of the Court having jurisdiction over such violation and the matter shall be set for hearing.
- **A.5** If the citation has not been paid at the Violations Bureau within 30 days of the date of issuance, the violation shall be filed with the Clerk of Superior Court and the matter will be set for initial appearance.

VIII. PARKS AND RECREATION

A. PARKS & RECREATION PROGRAM FEES & CHARGES

Program Fees & Charges (Refer to current Park Board-approved schedule of fees)

- **A.1** Applicable Metered Parking Fees (Ch. 54, Art. IV, Div. 3) All parking lots in Centennial Park in the Town are metered parking lots.
 - **a.** The fee to park in a metered parking lot is \$2.00 per hour or \$5.00 per day (including re- entry during the applicable hour or day).
 - i. A fifteen (15) minute grace period is allotted upon a vehicle's entry into a metered parking lot whereby parking fees will not be assessed if the vehicle exits the lot within the grace period. Parking fees will be assessed if the vehicle remains in the lot beyond the fifteen (15) minute grace period.
 - **ii.** Payment of the hourly or daily parking fee shall be made within 15 minutes of entry to the metered lot via the on-site parking meter kiosk, smartphone app (download <u>ParkbyApp</u> from the App Store or Google Play), website (<u>ParkbyApp.com</u>), or by phone (<u>1-888-764-ASTA</u>). If payment is made via the smartphone app, a convenience fee of \$00.50 will be accessed for each transaction. Payment will not be accepted by the town clerk-treasurer.
 - **b.** An annual pass to a metered parking lot may be purchased each calendar year. The fee for an annual pass to a metered lot shall be as follows, subject to all conditions of this division and the applicable parking management agreement:
 - **i.** *Residents*. One time each calendar year, Town of Munster residents are eligible to register the license plates of two (2) vehicles, per household, for an annual parking pass at no cost (\$0.00). Registration shall be completed each year through a link on the Town's website.
 - Residents may purchase annual parking passes for additional vehicles (vehicle 3, 4, etc.) per household, for \$20.00 per vehicle, per calendar year. Residents shall contact the Parks Department directly to register and obtain payment

- information for additional vehicles.
- **ii.** *Non-Residents*. Non-residents of the Town of Munster may register the license plate of a vehicle for an annual parking pass for \$120.00 per vehicle, per calendar year.
- **c.** The Director of Parks and Recreation is authorized to charge a daily rate of not more than \$5.00 per day to park in a metered parking lot on days that the parking meter equipment is non-functional.
