Re: replacement golf car purchase revision

The purchase of new golf cars was previously approved in November 2024 through the BuyBoard purchasing cooperative. After the recent theft of ten golf cars, we will no longer receive a trade-in credit since we have ten fewer golf cars to trade in. Attached is an updated proposal which adds the trade-in value of \$1,600 per unit for ten units to the previously approved cost for the new cars. The new purchase cost will be \$287,640.00. This is an increase of \$16,000 to the previously approved purchase cost. This item was included and budgeted for \$300,000 in the 2024 G.O. bond issue from the Town and the updated cost is still within that budgeted figure.

Recommendation:

Staff recommends approving of the attached fleet proposal from Golf Cars Plus c/o Yamaha Golf-Car Company's BuyBoard contract #706-23 for the purchase of 40 new golf cars and trading in of the current fleet of golf cars with the stipulations included in the attached proposal at a total cost of \$287,640.00.
